Definition of Disability:

Under Section 504 of the Rehabilitation Act of 1073 and the Americans with Disabilities Act (ADA), a person with a disability is defined as any person who has a physical or mental impairment that substantially limits one or more major life activities, has a record of such impairment, or is regarded as having such an impairment.

- Physical or Mental Impairment- (a) any physiological disorder or condition, cosmetic disfigurement, or anatomical loss affecting one or more of the following body systems: neurological; musculoskeletal; special sense organs; respiratory; including speech organs; cardiovascular; reproductive, digestive, genitor-urinary; hemic and lymphatic; skin; and endocrine; or (b)any mental or psychological disorder, such as mental retardation, organic brain syndrome, emotional or mental illness, and specific learning disabilities
- **Major Life Activities** functions such as caring for one's self, performing a manual task, walking, seeing, hearing, speaking, breathing, learning, and working
- **Major Bodily Functions** functions of the immune system, normal cell growth, digestive, bowel, bladder, neurological, brain, respiratory, respiratory, circulatory, cardiovascular, endocrine, and reproductive functions
- **Record of Impairment** having a history of or have been classified (or misclassified) as having a mental or physical impairment that substantially limits one or more major life activities. Individuals who take mitigating measures to improve or control any of the conditions recognized as a disability are still considered to have a disability and require accommodation.

Definition of Medicare Homebound Eligibility:

Having or had an injury or illness that makes it difficult to leave home; for example, the client:

- Requires the aid of supportive devices
- Requires the use of special transportation
- Needs the assistance of another person
- Has a condition that leaving home is medically contradicted
- Symptoms of the disease or disorder process worsen when leaving home (pain, shortness of breath, confusion)
- Some days they would be able to get out with help, but they don't always have consistent assistance.
